## LASC Referral Program

- LASC refers cases
   directly to MCLA for
   mediation. Cases must
   have a Notice of Referral.
- Services are offered at reduced or no cost.
- Mediators are Zoom trained.

#### Vendor Resource Program

- Selected by the Los Angeles Superior Court as a Resource Vendor for Civil Mediations since 2018.
- Enables cases to be assigned to a mediator and scheduled quickly and efficiently than other programs.

## HON. SAMANTHA P. JESSNER FORMER PRESIDING JUDGE, LOS ANGELES SUPERIOR COURT

Judge Jessner was appointed to the Los Angeles Superior Court in 2007. She is the immediate past Presiding Judge of the Court. She previously served as the Assistant Presiding Judge, Supervising Judge of the Civil Division, the Assistant Supervising Judge of the Civil Division, and the Supervising Judge of the Mental Health Courthouse. She also served in the Criminal Division.

Judge Jessner serves on the Supreme Court Committee on Judicial Ethics Opinions ("CJEO") and the Executive Committee of CJEO. She also is a member of the Information Technology Advisory Committee and the Civil and Small Claims Committee of the Judicial Council. Judge Jessner is a New Judge Orientation Instructor for CJER. She is also an instructor for CJER's ethics curriculum and has served on the Qualifying Ethics Work Group that develops and designs ethics curriculum. In addition, Judge Jessner teaches the Civil Law Update and Basic Civil Law Overview seminars for the Rutter Group.



A member of the State Bar of California since 1966 and the San Fernando Valley Bar Association since 1996, Mr. Sankary has also been involved with the Provisors National Network of Professionals since 2000. Mr. Sankary's distinguished career in Alternative Dispute Resolution (ADR) began in 1985 with family law mediation.

MCLA celebrates Mr. Sankary's retirement, reflecting on his numerous accomplishments and expressing our gratitude for his unwavering dedication to justice and community service. In the field, he is celebrated for integrating social and cognitive science into mediation practices, shaping the way conflicts are resolved.

## ENRIQUE G. KOENIG ERICH AND DELLA KOENIG FOUNDATION

Enrique has many years of experience as a mediator providing mediation services in the greater Los Angeles area. Early in his career, Enrique served the Los Angeles County Superior Court as a volunteer in the party-select program. Thereafter, Enrique developed his training and practice in the family arena. He was admitted to The Association for Conflict Resolution in 2014 as an Advanced Family Practitioner. He then became a certified advanced family practitioner member of The Academy of Professional Family Mediators. Enrique is also a mediation panel member of Southern California Family Mediation beginning in 2017, serving families within the child dependency system in Los Angeles. He also provides mediation services in adoption related conflicts. Family dependency and adoption cases are unique and very complex cases to mediate. They usually involve parties that are in high conflict situations that require specialized training and skills that can only be developed over time. Enrique obtained MC3-Certification in 2022. MC3 focuses on an individual's education, training and practicum exclusively within the area of mediation. In addition, Enrique has been inducted to AAAMediation.org as an affiliate member.
